**ORDER REGARDING CERTAIN MOTIONS FOR EXCLUSION**

This matter having come before the Court on February 7, 2001 at 1:00, it is hereby ordered as follows:

1. Pursuant to the Court's January 4, 2001 Order, the Receiver was ordered to post a list of all pending exclusion motions, and the Receiver's recommended disposition with respect thereto, on the Intrust website on or before January 8, 2001. The Receiver has posted such list.

2. Also pursuant to the Court's January 4, 2001 Order, all account holders who disagreed with the Receiver's recommendation in its January 8, 2001 list were to file a response with this Court on or before January 22, 2001. Account holders who did not file such a response would have their exclusion motions disposed of as recommended by the Receiver.

3. The Receiver has reviewed all responses to its January 8, 2001 list, and has identified those accounts that did not file a response. Accordingly, the following accounts are hereby deemed to be included or excluded in the allocation of the cash trust fund shortage as noted:
